Time Limitations

Comments shall be limited to 5 minutes. In circumstances when the person has given advance notice of the need to speak for a longer period of time, such person may be allowed to speak more than 5 minutes. The Board Chair can lengthen a person's opportunity to speak.

Anyone wishing to speak regarding an item on the agenda may do so when the Board Chair addresses Public Comment on Business Items. If you would like to comment on a particular agenda item, please either raise your hand or stand so that the Board Chair can address you.

Citizen Participation – Non Agenda Items

Anyone wishing to speak regarding items not on the agenda may do so when the Board Chair addresses Public Comment. If you would like to comment, please raise your hand or stand so that the Board Chair can address you.

Rules of Conduct

2. Remarks by any person addressing the Board which reflect adversely upon the racial, religious, economic, or political views, character or motives of any employees or the Board at the meeting will be considered out of order.
